Woodplumpton Parish Council's Newsletter October 2020

A warm welcome to the October edition of the Parish Council Newsletter which updates new and existing residents on matters concerning the Woodplumpton Parish area. We usually issue the Newsletter on a quarterly basis but earlier editions were cancelled due to Coronavirus. Inside this edition there is an opportunity for you to comment on a proposed **Neighbourhood Plan** to help us in our response to local planning applications. You can also learn how to find about road closures including the **closure of Sandy Lane** from the **2nd Nov until the 25th Jan 2021.**

Parish Council Meetings

Whilst the Council has been unable to hold face to face meetings, we have continued to meet remotely via Zoom with the Agenda and Minutes published on our website www.woodplumptonparish.org

Meetings take place on the **3rd** the month and start at **7.00pm**. Members of the public may observe the **Monday** of meetings and there is usually a **time limited** session for public participation. Residents are requested to notify the Clerk of any issues or concerns **in advance** of the meeting, as matters requiring a Council decision must be included on the Agenda at least 4 days prior to the meeting taking place. Further information is available from the Parish Clerk.

Coronavirus

Obviously Coronavirus has had an impact on local events and regrettably the **Woodplumpton Village Fete** which takes place in September, was cancelled. Discussions are taking place to see if a Christmas event can be held and we will issue a further update in the winter edition of our Newsletter along with details of any **Christmas Carol Services**.

Frustratingly, we have been unable to make further progress on the proposed **Traffic Calming schemes.** Councillors have worked closely with LCC Highway officers to agree measures to reduce the volume and speed of traffic travelling throughout the villages, but just as we were about to finalise the schemes and costs involved, LCC officers were redeployed to Covid related traffic issues and we are waiting for them to confirm when we can resume the actions to progress the works.

Police Incidents

Woodplumpton has always been a rural area which benefits from very little crime, however, with the all the new homes being built, we are seeing an increasing number of 'visitors' to the area. Initially this related to **thefts from the building sites**, but as the homes become occupied, we are getting several reports of opportunist thefts through **insecure sheds**, **car doors and windows especially during warm weather**.

As police resources are deployed to areas with the most incidents or crimes, we urge residents to **report any local concerns** no matter how insignificant, as this will help the Parish retain a local police presence.

Neighbourhood Watch Scheme

Residents on the new estates may also be interested in setting up a Neighbourhood Watch Scheme. To set up a scheme, a resident needs to be appointed for each road or small area of an estate. The resident, supported by an experienced NHW co-ordinator, contacts residents in the specified area and people are encouraged to pledge support for the scheme. The resident co-ordinator will be issued with signs and stickers which residents are encouraged to display. Participation in the scheme can lead to a reduction in household insurance. Hedge cutting, street lights and potholes

Lancashire County Council is responsible for repairing pot holes and ensuring that overgrown hedges are cut back. Residents can easily report these matters directly to LCC, along with **street lighting issues, blocked drains and mud on the road.** Simply use this link, select the appropriate concern and enter the location on the map. Once you have submitted the details you will receive a reference number by email which allows you to check on any progress. <u>www.lancashire.gov.uk/roads-parking-andtravel/report-it</u>

Although the recycling centres are now open, **fly tipping** has increased. You can log the location of an incident online at <u>www.preston.gov.uk/</u> <u>article/899/Report-fly-tipping</u> or call 01772 906909 to get it removed.

Alternatively, if you are unsure who to report the issue to, you can report it on https://www.fixmystreet.com and they will forward the problem to the correct authority.

In addition to the **Community Infrastructure Levy**, the Parish Council is funded through a **Precept** collected through the City Council Tax.

In accordance with Local Government legislation, our budget, expenditure and audit information are all published on our website <u>www.woodplumptonparish.org</u> under 'documents / finance'.

The **2019/20** external audit has just been completed and a summary of the accounts is included below.

The financial year started with a carried forward balance of \pounds 387,858 of which CIL monies totalled \pounds 353,431 leaving Council reserves of \pounds 34,427. Income and expenditure for 2019/20 is itemised below.

During **2019/20** the Council received **£130,652** in CIL monies and spent **£15,000** on LCC's traffic calming plans leaving the 2019/20 CIL balance as **£469,083** This money has been earmarked for traffic calming schemes in both Woodplumpton and Catforth Villages.

The year-end balance of **£527,006** less the CIL balance of **£469,083** leaves the Council with reserves of **£57,923** however **£33,300** relates to the **2020/21** Precept which was paid before the 2019/20 year end due to Covid 19. This leaves the Council with actual reserves of **£24,623**

Environment Agency

The Environment Agency is continuing to monitor odour complaints at Ambrose Hall Farm following a change in farming practices. A Complaints Procedure and Odour Complaint Form are included in the **Odour Management Plan** which can be viewed on the Parish Council website. Mr Leeming is happy to speak to residents and can be contacted on **01772 690111**, however, to ensure an accurate log is recorded, incidents must also be reported to the Environment Agency on **0800 807060**.

Bartle Hall Application

Residents may be aware of a planning application to create a new roundabout and up to 1100 homes on land near to Bartle Hall. The application also has an option to build 1050 homes and a primary school but as we know from NW Preston, applications were approved with 'options' to build schools, a health centre and community facilities - but none have materialised.




The Parish Council feels that Woodplumpton has taken its fair share of new housing development and given the proximity of the land to the M55, believes that if the land is developed, it should be for employment use as an out of town shopping complex, leisure / health facilities or business opportunities. Road Closures

The Parish Council is notified of **major** roadworks and we try to include these on our website, however we are not always notified of minor road works in relation to utility works to the new developments but you can check progress on these on the County Council website <u>www.mario.lancashire.gov.uk/roadworks/bulletin.aspx</u>

LCC have advised us that they propose to construct the East - West link road junction with Sandy Lane over the winter months from the **2nd Nov until the 25th Jan 2021.** Most of the works will be ongoing and will allow access to **Maxy House Road** from the South / Post Office end of Sandy Lane. However they have advised that "they will also be installing a drain along **Sandy Lane** from the junction to an outfall south of Maxy House Road. For a time during that period, **it will be necessary to change the access to come from the north".**

In response to our query regarding the notification of residents and local businesses, LCC replied, "Costain who will be carrying out the works, operate an excellent communications team and will keep residents informed of the timing of the changes to the access routes.

NEIGHBOURHOOD PLAN

A Neighbourhood Plan is a planning document which provides **Planning Policies for the Parish Council area** in addition to the Planning Policies that cover Preston as a whole. This means the Parish Council can **influence and shape the growth** of development outside the NW Preston area, to **ensure the rural character of the Parish is retained.**

As part of the Neighbourhood Plan process, the Parish Council can protect and enhance the green, open spaces and can identify the local heritage and contribution to the economy. The Parish Council is also keen to ensure that all residents have an easy access to footpaths and cycleways to the facilities and amenities in the NW Preston area to encourage a united community and reduce traffic congestion. Further information is detailed in the Vision and Objectives on the adjoining page.

Developers must pay a **Community Infrastructure Levy** to the City Council to improve the roads and community facilities in the area affected by development. Currently the Parish Council receives 15% of this - capped at £100 per property on the electoral register. The remainder of the fee is passed directly to Lancashire County Council.

If the Parish Council adopts a Neighbourhood Plan, the Parish Council receives 25% of the fee - uncapped - which means a substantial amount of funds can be spent entirely in the Parish Council area, allowing the Parish Council to improve, provide and support initiatives which will help us to deliver the Policies in the Neighbourhood Plan.

The Neighbourhood Plan can only be adopted if it is supported by the majority of Parish Council residents and following an initial consultation on the draft Policies in July last year, we now invite you to comment on the pre-submission consultation. This is probably **the biggest opportunity** the Parish Council has had to **influence and provide new facilities and infrastructure** in the area and we hope everyone will engage as fully as possible.

The Consultation will be available from **5th October** for 6 weeks until the **13th November.** You can download a copy from our website <u>www.woodplumptonparish.org</u> along with a **Character Assessment**.

Hard copies are also available from the Parish Councillors or you can ask to view a copy in Woodplumpton and Catforth Primary Schools, Ashbridge and Cottam nurseries and the site office of the new estates.
